



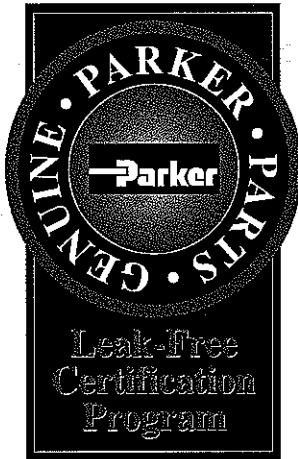
Leak-Free Certification Program

You have purchased the highest quality equipment available today. As a subscriber to total quality improvement, the manufacturer has equipped this unit with Parker leak-free fluid connectors. The connectors are engineered and manufactured by Parker to provide leak-free service and are covered under the Genuine Parker Parts (GPP) program.

The GPP program is Parker Fluid Connectors Group's leak-free certification program. Certification of this unit under the GPP program covers all Parker Fluid Connectors Group elastomeric-sealing products to be free from defects in materials and workmanship for up to three years (36 months).





Genuine Parker Parts Warranty

Parker's Genuine Parker Parts (GPP) exclusive leak-free warranty comes at no extra cost to you and is the result of continuous quality enhancements by the manufacturer of this piece of equipment.

Parker's Leak-Free program warrants all elastomeric-sealing connection points throughout the hydraulic and/or pneumatic system of this unit that use Parker Fluid Connectors products. These sealing surfaces are guaranteed to be free of leakage for a period of up to three years (36 months) from date of purchase when properly assembled. This covers all Parker Fluid Connectors Group elastomeric-sealing products.

Warranty Registration

To be eligible for Parker's exclusive leak-free warranty, you must complete and submit the warranty registration information form on the Parker GPP website: www.parker.com/gpp. Submission of the registration information activates the equipment coverage and begins the leak-free warranty period. Once the registration is received by Parker, you will be contacted by a Parker representative who will explain the warranty procedures, including how to handle the process in the unlikely event of a warranty claim.

Should leakage occur from any of these components manufactured by Parker, please follow these steps:

- **Visually inspect parts for external damage or abuse.**
- **Ensure tube fitting/hose assembly is properly assembled to its mating part.**
For Parker Seal-Lok™ fittings, the O-ring in the face of the adapter must be inspected prior to proper tightening. The possibility of a damaged O-ring exists if the connection was found to be loose. It is recommended the O-ring be replaced and the connection properly tightened prior to pressurizing the system.
- **If you have taken these steps and are unable to terminate the leak, simply remove the leaking part(s) and replace it (them) through the original equipment manufacturer/dealer or the local Parker Fluid Connectors distributor. The local Parker Fluid Connectors distributor location can be found by calling 1-800-C-PARKER.**
- **The failed components must be saved and will be returned to Parker by the distributor, dealer or equipment manufacturer.**
- **Upon receipt and verification of the failed components, the invoiced amount for the replacement part(s) will be reimbursed to you. Please allow 45 days for processing.**
