

#### OPERATING INSTRUCTIONS Model 807016 Truck Brake Drum Cleaner

Mount the head assembly on to the portable stand. Height adjustment is determined by measuring the height of the truck wheel axle after the tires have been removed. Adjust hood to proper height and insert pin No. 20 through holes in dolly cart.

Attach 2" vacuum hose to inlet No. 24 and to H.E.P.A. Vacuum. Attach air hose with quick coupler to pressure regulator No. 15 maximum air pressure 50 PSI through 1/4" - 3/8" air line. Pressure can be regulated to maintain negative pressure and CFM within the hood assembly while the vacuum is in operation. Always maintain negative pressure within the hood. Check air flow aperture opening No. 17 while vacuum is attached and turned on and the air pressure blowing nozzle is turned on. Air flow direction must be into the hood at all times. Air blowing out of the hood would indicate to high a pressure and CFM volume from the blowing nozzle.

With vacuum turned on roll hood assembly up to the truck axle, this should be directly in the center of the hood assembly. With both hands outside the hood, stretch the rubber diaphram to below the axle and the brake assembly into the hood. When the brake assembly is totally encapsulated, insert your hands into the non-permeable gloves using the blowing nozzle, blow all the asbestos dust out of the brake assembly. Using a circular motion allow the dust that may be left around the inside of the hood itself, then blow out the brake assembly again to be sure you have removed all traces of asbestos dust before removing the hood assembly. Remove the hood assembly while the asbestos recovery vacuum is still on.

#### DANGER
