

When using an electrical appliance, basic precautions should always be followed, including the following:

READ ALL INSTRUCTIONS BEFORE USING

WARNING - To reduce the risk of fire, electric shock, or injury:

• Do not leave appliance when plugged in. Unplug from outlet when not in use and before servicing.

WARNING

To reduce the risk of electrical shock - Do not expose to rain. Store indoors.

- Do not allow to be used as a toy. Close attention is necessary when used by or near children.
- Use only as described in this manual. Use only manufacturer's recommended attachments.
- Do not use with damaged cord or plug. If appliance is not working as it should, has been dropped, damaged, left outdoors, or dropped into water, return it to a service center.
- Do not pull or carry by cord, use cord as a handle, close a door on cord, or pull cord around sharp edges or corners. Do not run appliance over cord. Keep cord away from heated surfaces.
- Do not unplug by pulling on cord. To unplug, grasp the plug, not the cord.
- Do not handle plug or appliance with wet hands.
- Do not put any object into openings. Do not use with any opening blocked; keep free of dust, lint, hair, and anything that may reduce air flow.
- Keep hair, loose clothing, fingers, and all parts of body away from openings and moving parts.
- Do not pick up anything that is burning or smoking, such as cigarettes, matches or hot ashes.
- Do not use without dustbag and/or filters in place.
- Turn off all controls before unplugging.
- Use extra care when cleaning on stairs.
- Do not use to pick up flammable or combustible liquids such as gasoline or use in areas where they may be present.
- Connect to a properly grounded outlet only. See grounding instructions.

SAVE THESE INSTRUCTIONS

INSPECTION

Carefully unpack and inspect your machine for shipping damage. Each unit is tested and thoroughly inspected before shipment, and any damage is the responsibility of the delivery carrier who should be notified immediately.

ELECTRICAL - 115 Volt

This machine is designed to operate on 15 amp. 115 volt, 60 hz, AC circuits. Voltages below 105 volts AC or above 125 volts AC could cause serious damage to the motor.

ELECTRICAL - 240 Volt

This machine is designed to operate on a standard 16 amp. type L fused 230 volt, 50 hz, AC circuit. Voltages below 200 volts AC or above 250 volts AC could cause serious damage to the motor. I.E.C. Class I.


WARNING

Electric motors can cause explosions when operated near explosive materials or vapors. Do not operate this machine near flammable materials such as solvents, thinners, fuels, grain dust, etc.

GROUNDING INSTRUCTIONS

This appliance must be grounded. If it should malfunction or breakdown, grounding provides a path of least resistance for electric current to reduce the risk of electric shock. This appliance is equipped with a cord having an equipment-grounding conductor and grounding plug. The plug must be plugged into an appropriate outlet that is properly installed and grounded in accordance with all local codes and ordinances.

DANGER - Improper connection of the equipment-grounding conductor can result in a risk of electric shock. Check with a qualified electrician or service person if you are in doubt as to whether the outlet is properly grounded. Do not modify the plug provided with the appliance -- if it will not fit the outlet, have a proper outlet installed by a qualified electrician.



TWIN MOTOR LID DRY ONLY

(Follow schematic on page 11, figure 1)

For the benefit of your health, you should always wear a face mask approved for use with the toxic dust you may be recovering any time you are using or cleaning this vacuum cleaner. Check with your safety department or industrial hygienist for specific requirements for your application.

PREPARING VACUUM FOR USE


- 1. Place vacuum lid assembly #1 on worktable upside down.
- 2. Place pink impact filter #3 onto H.E.P.A. filter #2.
- 3. Center filter screen over impact filter and lock on with clamp #4.
- 4. Place adaptor ring #7 on worktable with locking latches up.
- 5. Insert filter bag protector #6 into adaptor ring and drape elastic over rim about one inch.
- Place cloth filter bag #5 into adaptor ring and center to seat gasket around rim of adaptor.
- 7. Place adaptor ring assembly #7, with filter protector and cloth bag, onto the underside of the vacuum. Center adaptor ring and clamp locking latches to underside of lid.
- 8. Vacuum lid assembly is now ready for dry recovery cleaning. Place vacuum lid on 55 gallon drum.

PROCEDURE FOR CLEANING AND REPLACING FILTERS


(Follow schematic on page 11)

- 1. Unplug electric cord from wall receptacle.
- 2. Remove vacuum lid assembly from 55 gallon drum and place on worktable upside down. If another H.E.P.A. filter vacuum is available, vacuum underside of lid and adaptor before disassembly or removing adaptor ring.
- 3. Detach clamp locking latches which are holding the adaptor ring #7 on the underside of the vacuum lid.
- 4. Remove cloth filter bag #5. If filter bag is soiled, you will need to vacuum it with a crevice tool after vacuum has been reassembled. A replacement filter bag should be kept on hand for this purpose. If another H.E.P.A. filter vacuum is available, clean the soiled filter bag as soon as you remove it.
- 5. Remove filter bag protector #6 from adaptor. Disposal of the filter protector must be handled the same as other hazardous materials.
- 6. Vacuum clean the adaptor ring #7 or wipe down with damp towels.
- 7. Inspect pink impact filter #3 on H.E.P.A. #2. If impact filter shows discoloration due to penetration of material you are recovering, replace it with a clean new filter. Disposal of impact filter must be the same as hazardous material you are working with.
- 8. Inspect H.E.P.A. filter #2 for soil penetration. Do not attempt to clean H.E.P.A. filter in any way. H.E.P.A. filter requires changing only when it becomes clogged due to penetration of dust particles through all the prefilters. Loss of vacuum performance after all the prefilters have been changed would indicate the need for replacing the H.E.P.A. filter.
 - DANGER: Hazardous toxic dust material must be disposed of properly. Never throw hazardous waste materials into your usual trash receptacle. Place debris in a plastic bag (6 mil for asbestos) or container marked with the type of HAZARDOUS MATERIAL, and contact a certified hazardous waste handler for final disposal.
- 9. Follow assembly instructions to put your vacuum back into service. Do not operate your vacuum unless all filters and prefilters required are in place at all times.

Twin Motor Lid Wet or Dry, refer to figure 2, page 12 for assembly.


