To answer your Questions:

The official description is as follows:

The old engine was D902-E3B-KEA specification. This is a standard warehouse engine from Kubota

The New Engine is D902-E4B-PBS1 specification. This is a Specific engine for Powerboss applications

Serial number break is not obtainable. The reason for this is that you started using the PBS spec and then requested 21 of the old spec etc.

The use of the new engine was intermittent. Therefore I provided you a list of all serial numbers of the new PBS spec engine that was sold to you.

The reason the temperature switch is installed and part of the new spec is that it was a request from your engineering team.

A shutdown system was an option that was sold by your team. We leave the temperature switch in the unit because we are not sure how the engine is sold. It would be up to you to remove the switch if not used.
